- b. "Declaration" shall mean any Declaration of Covenants and Restrictions as amended from time to time, affecting any portion of HUDSON LAKE ESTATES a subdivision in Jefferson County Kentucky.
- c. "Tract" shall mean each subdivided lot or similar property, the owner of which is a member of the Corporation pursuant to the Declaration.

ARTICLE IV

The corporation is organized for the purpose of promoting the social welfare, common good, health and safety of the members of the corporation, and to construct, operate, maintain and repair any common area, including roadways, whether owned by the corporation or not, as contemplated by the Declarations.
